



**LIABILITY WAIVER and Authorization, Consent and Release for use of visual likeness and original works of minors and participants:**

I, the undersigned, on my own behalf and/or as the parent/guardian of the minor so named (the "Participant"), hereby agree to the following:

**COMPLETE WAIVER, RELEASE, AND COVENANT NOT TO SUE.** In consideration of MN Catholic Youth Partnership/ Trinity Woods Catholic Retreat Center permitting the Participant to be present upon and use the facility located at N10884 Hoinville Rd, Trego, WI 54888 (the "Facility"), and/or participate in the Activities (as defined below) I, on my own behalf and on behalf of Participant if a minor, hereby waive liability on the part of, discharge and agree not to sue or to execute upon any judgment against, and release MN Catholic Youth Partnership/Trinity Woods Catholic Retreat Center, its employees, representatives, directors, instructors, successors, or assigns (collectively, "MNCYP"), from any and all liability, loss, injury, death, damages, costs, expenses, including costs and attorneys' fees, causes of action, and claims of any kind or type, which may have arisen, or may arise for any reason, including, without limitation, due to any acts of passive or active negligence on the part of MNCYP, while the Participant is present upon or using the Facility and/or participating in the Activities.

**ASSUMPTION OF RISK.** I am fully aware that there may be risks and hazards associated with being present upon and using the Facility, and I, or the Participant, elect to voluntarily be present upon and use the Facility knowing that there may be risks or hazards. I further understand that while present upon the Facility, I, or the Participant, may voluntarily participate in activities offered by MNCYP, which activities may include, but are not limited to, a challenge course, zip line course, golf cart operation, laser tag, archery tag, canoeing, paddle board, kayak, swimming, Wibit water inflatables, hiking, biking, outside bonfires, and waterfront and/or aquatic center use, and any other activities which may occur at the Facility (each an "Activity" and collectively, the "Activities"). I acknowledge and agree, on my own behalf and on behalf of the Participant, that the Activities are inherently dangerous and subject the Participant to physical exertion and the possibility of physical illness or injury, ranging from minor to serious or catastrophic injuries and/or death. Risks include, but are not limited to, drowning, falling, injuries resulting from latent or apparent defects or conditions in equipment or property supplied by MNCYP, and injuries resulting from Participant's own physical condition and skill level and Participant's own acts or omissions. I, on my own behalf and on behalf of the Participant, acknowledge that the Participant is assuming the risk of such illness or injury and agree to bear full responsibility and sole liability for any death, bodily injury, illness, or damage incurred by Participant.

I, ON MY OWN BEHALF AND ON BEHALF OF THE PARTICIPANT IF A MINOR, UNDERSTAND THAT THIS IS A COMPLETE RELEASE OF ANY AND ALL POSSIBLE CLAIMS AGAINST MNCYP AND THAT I, ON MY OWN BEHALF AND ON BEHALF OF PARTICIPANT IF A MINOR, EXPRESSLY RELEASE ANY CLAIMS RELATED TO ANY INJURIES PARTICIPANT MAY SUFFER FROM THE PASSIVE OR ACTIVE NEGLIGENCE OF ANYONE IN CONNECTION WITH THE FACILITY OR ACTIVITES.

I grant the following rights to Minnesota Catholic Youth Partnership doing business as Trinity Woods Catholic Retreat Center: The right to use all photographs, pictures, portraits, vocal sounds, appearances/likenesses, video and performances (hereinafter collectively known as 'image') of My Child in the possession of Trinity Woods taken at Extreme Faith Camp or another retreat at our facility. The right to use, reproduce, publish, exhibit, distribute, and transmit the image of My Child individually or in conjunction with other images or printed matter in the production of brochures, slides, motion pictures, broadcasts (radio, television, and other social and digital media), audio or video files, recordings, still photography, CD-Rom and any other manner of media now known or later developed; The right to use, reproduce, publish, exhibit, distribute, and transmit the image of My Child individually or in conjunction with other images or printed matter on Minnesota Catholic Youth Partnership doing business as Trinity Woods Catholic Retreat Center Internet websites. No last name, home address or phone number will be published; The right to copyright, in the name of Trinity Woods Catholic Retreat Center and Minnesota Catholic Youth Partnership, works that contain the image of My Child; The right to use and publish for general communications, advertising, commercial or publicity purposes, or for any other lawful purpose whatsoever My Child's original work; and The right to assign the above-mentioned rights to third parties without notice to me. I understand that the video files, still photos, or other media incorporating the image of My Child will become the property of Minnesota Catholic Youth Partnership doing business as Trinity Woods Catholic Retreat Center. I hereby waive the right to inspect or approve the image or any finished materials that incorporate the image. I understand and agree that no compensation will be provided, now or in the future, in connection with the use of My Child's image or My Child's original work. I hereby release, discharge, and agree to indemnify and hold harmless Minnesota Catholic Youth Partnership doing business as Trinity Woods Catholic Retreat Center, and their agents, employees and assigns from any and all claims, demands, right, and causes of action of whatever kind that I or My Child have or may have or may arise by reason of this authorization and from the use of My Child's image and original work, including but not limited to, all claims for libel and invasion of privacy. I hereby authorize and consent that Minnesota Catholic Youth Partnership doing business as Trinity Woods Catholic Retreat Center have the right to use My Child's name in connection with their educational, promotional, fund-raising activities, or for any other legitimate purpose. I, on my own behalf and on behalf of Participant if a minor, hereby represent and warrant that I have read this Liability Waiver in its entirety and fully understand its contents.
